




- Give multi-year unrestricted funding.

Evaluation in TBP: Alternative ways to capture learnings... why?

- To reduce grantee burden
- To demonstrate trust and humility
- To build stronger, deeper relationships

- To gain a bigger picture understanding of the issues
- To listen for ways to support grantees' impact goals

Evaluation in TBP: Alternative ways to capture learnings...*how?*

- Put onus on funder staff
- Reduce / eliminate narrative reporting requirements – consider what isn't necessary
- Implement alternative methods (oral reporting, focus groups, videos)
- Recognize the value of stories as data
- Check for understanding and alignment

Evaluation in TBP: Headwaters Foundation 3 Pillars of Learning & Evaluation

Learning for	Key Questions	Frequency
Accountability	 → How well are we living into our values? → Do our partners trust and value our support? 	Quarterly
Decision Making	 →How well are we supporting our nonprofit partners in achieving their goals? → How well are we strengthening the nonprofit ecosystem? 	Yearly
Long-Term Impact	 → What changes are we seeing in policies, practices, and systems over time? → How can partners help us interpret and act given these long-term data? 	5-10 years

Evaluation in TBP: Satterberg Foundation Early Experience

CHANGES

- 1. Eliminated written report
- 2. Slowed pace and promoted reflection
- 3. Realized changes in foundation infrastructure needed



RESULTS

- 1. Yearly check-ins
- Included time for deeper consideration of community needs, staff sabbaticals = appreciated by staff and identified new community priorities, e.g. own homes
- 3. Need to decrease # foundations per program staff

Evaluation in TBP: American Jewish World Service Structural Shifts

- Grants management system simplified, with burden of information gathering moved to staff (vs. grantees)
- Internal evaluation and program teams form deep partnership
- Decision making on awards and leadership on grantee and accompaniment and learning to local staff
- Happens in pieces/steps


